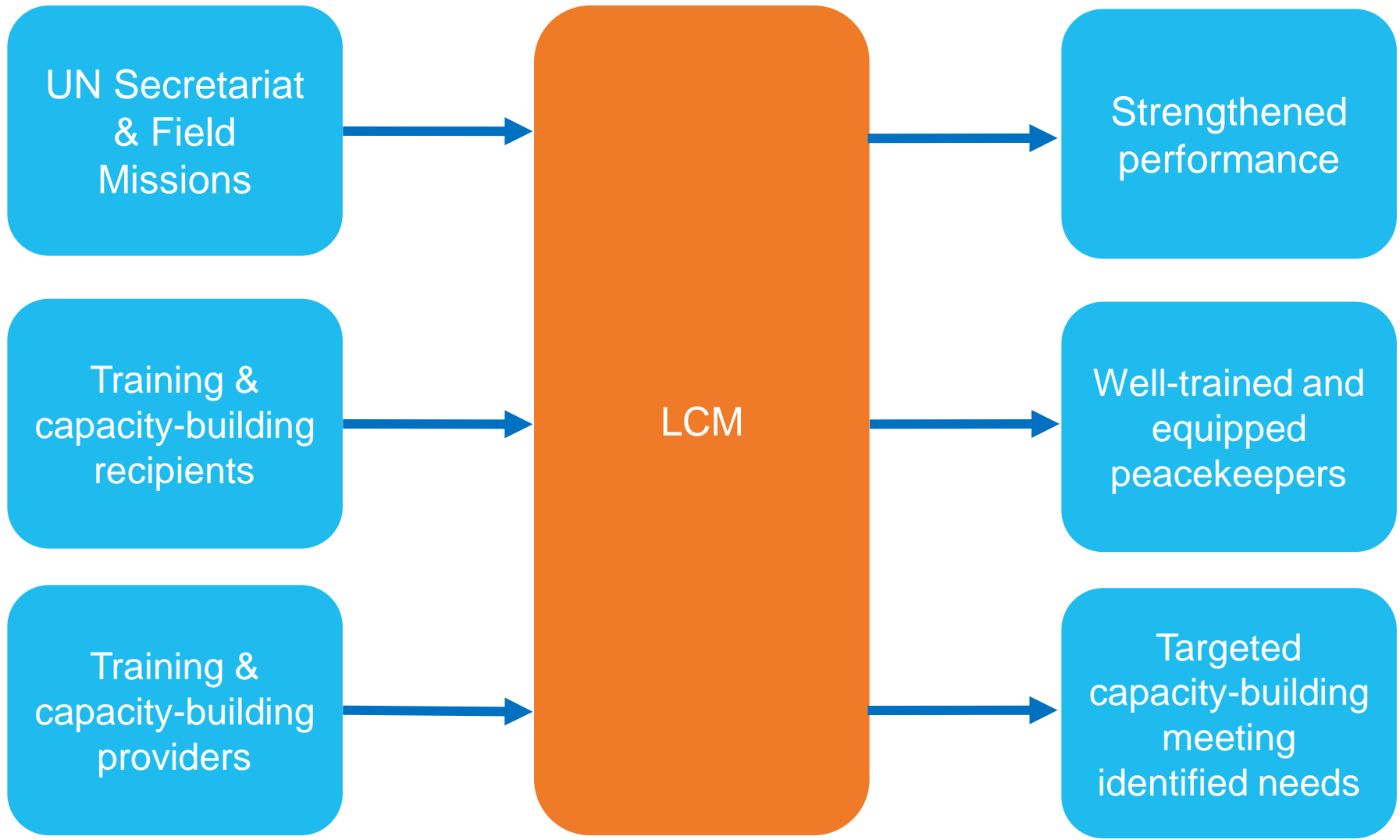

LCM Purposes

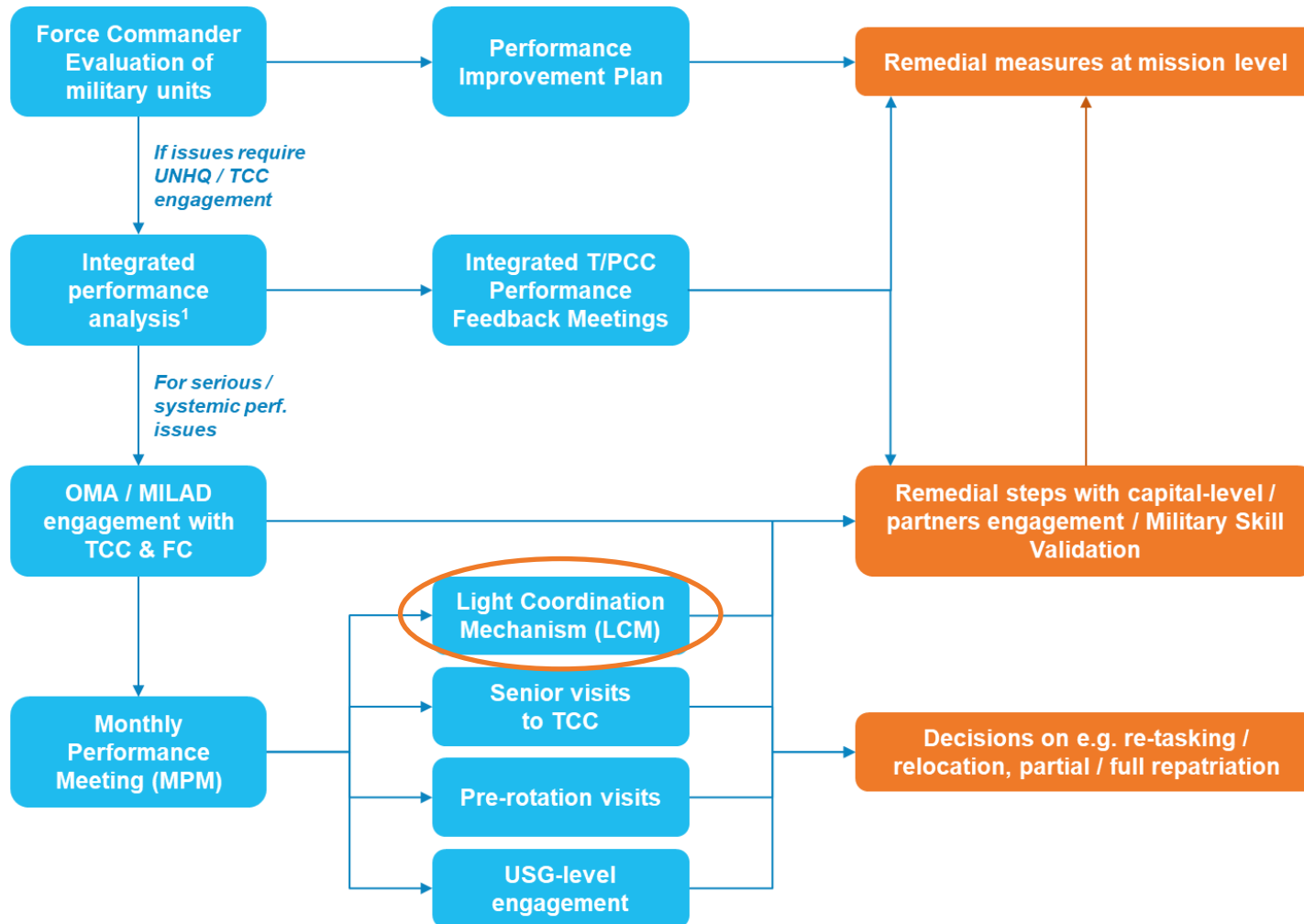
- Facilitate **bilateral and multilateral** partnerships between T/PCCs and Member States in order to provide training and capacity building support including financial, logistical (infrastructure), equipment
- Address **short- and medium-term needs** identified by the Secretariat and T/PCCs impacting mandate delivery
- Assist in **deconflicting** training and capacity projects, **match providers and recipients** based on planned activities
- Set up **rosters of assistance** based on declared capacity and expertise
- Ensure that training support is delivered in line with the **latest UN training standards**

LCM role related to Military Performance

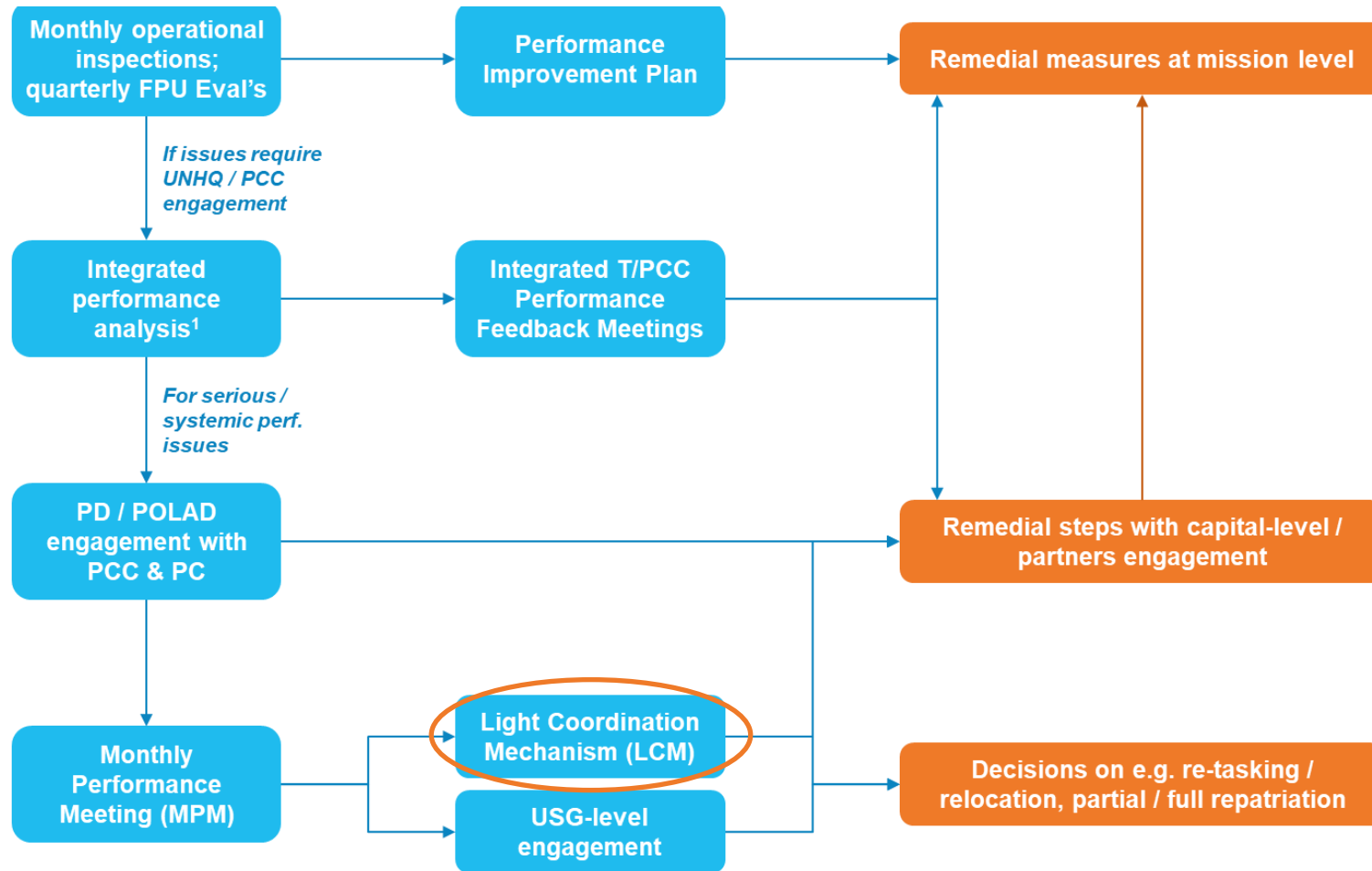

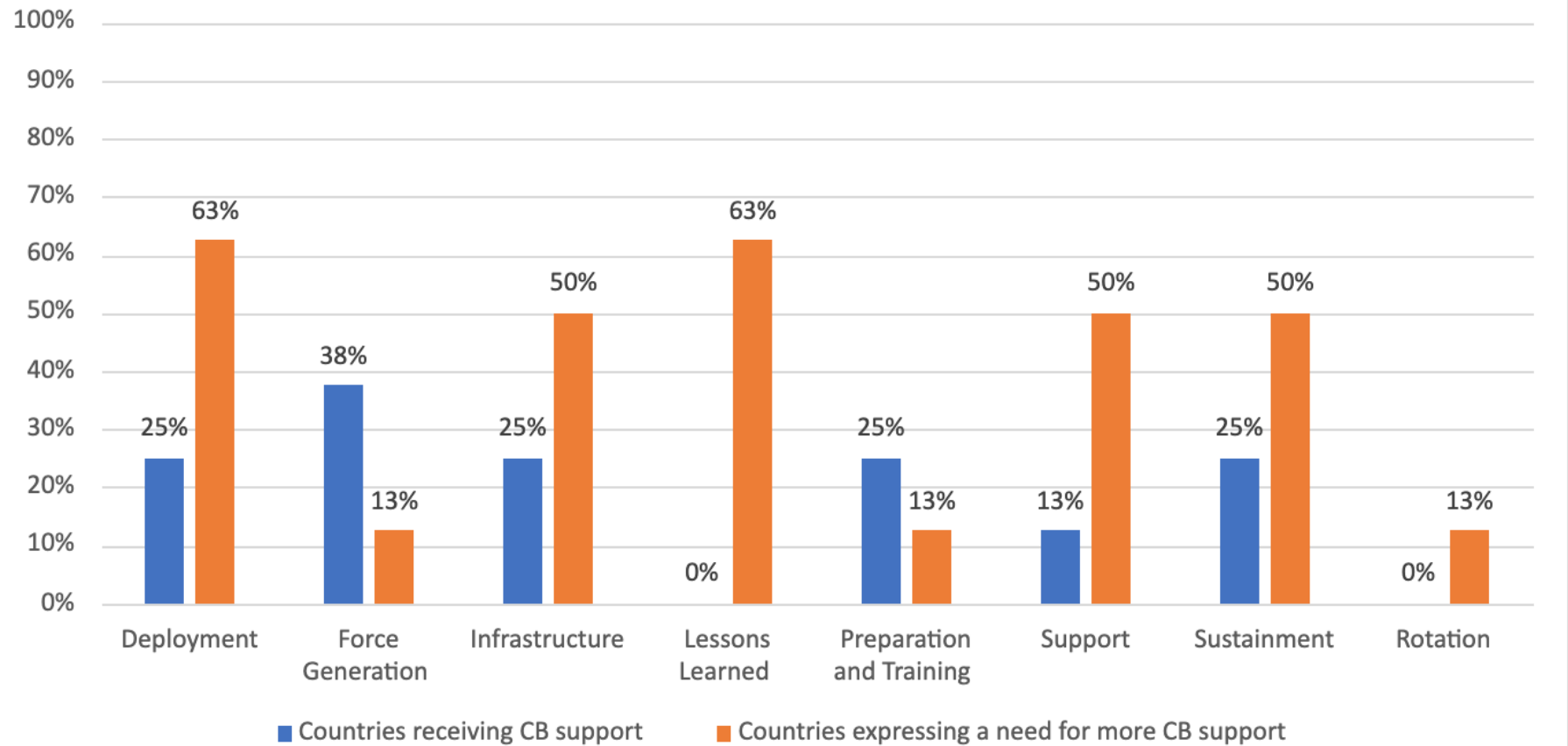

The Deployment Review Mobile Application

- Gap identified by Member States on lessons learning
- Request for increased lessons learning support
- LCM worked in collaboration with 16 Member States over two (2) years to address this gap
- Need to provide T/PCCs with the blue-print of an accessible knowledge sharing methodology, complementing existing information-sharing system when available

C34 Recommendations on Safety and Security

- **The Special Committee requests** to reinforce resilience of the UN peacekeeping missions against new security challenges by strengthening their capacities to respond to such threats, including **by implementing short lessons learned**. [para 178]
- the Special Committee takes note of the introduction of the **UN Deployment Review mobile app** to enable fast dissemination and implementation of lessons learned amongst military and police personnel and training centers. [para 178]
- **The Special Committee encourages missions and training centers to integrate lessons learned** cycles into tactics, techniques and procedures and adjust associated training requirements in the shortest amount of time, including through in-mission training, to improve the safety and security of UN peacekeepers. [para 178]

Launch of LCM Dialogue Series in 2024

DPO Standard Operating Procedure (SOP) on Member State-provided Military Mobile Training Teams (MTTs) *(in effect as of 1 September 2022)*

- **A Member State-provided Military MTT** is a technical assistance team composed of training experts provided by one or more Member State(s) and deployed to a peacekeeping mission on an exceptional basis and in coordination with the Secretariat to address training requirements needed for the effective delivery of mandated tasks.
- **Legal status:** “Personnel provided by a Member State to perform services as members of an MTT shall be engaged as **type II gratis personnel** [...]. While performing functions for the Organization as MTT members, the gratis personnel shall have the status of **experts on mission** [...]”
- All costs to be borne by Member State supplying MTT experts

DPO Standard Operating Procedure (SOP) on Member State-led Mobile Training Teams (MTTs)

- **Process as it relates to Member States**

- Member States interested in contributing MTTs to request via Note Verbale to be included in a roster (update every 2-years) starting January 2023
- If selected from roster, MTT members to be screened for conduct and discipline issues and approved by Office of Human Resources/DOS
- MTT Terms of Reference to be coordinated with TCC, DPO and approved by mission Force Commander
- Memorandum of Understanding to be signed by MS and USG of DPO
- During deployment, MTT leader to report progress to Force Commander
- Upon conclusion of deployment, final report and self-evaluation to be submitted

Information Sharing of Training Activities (T/PCCs): LCM Online System

- 24/7 **information sharing system** with individual log-in for Member States and conflict/duplication alerts
- To be developed together with OITC and piloted in 2023
- Will allow
 - Member States to enter their training calendars directly
 - To reduce the amount of coordination meetings
 - To ensure that the details provided are accurate and updated
 - manual and automatic identification of potential conflict and partnership opportunities
